Course	The essence of the course Internal Market of the European Union (EU Single Market) is to clearly differentiate the functioning of the Common Foreign Trade Policy of the EU as the basis of the customs union from the four economic freedoms: free movement of goods, services, capital and labor force as the basis of the Internal Market of the EU. Each of the four freedoms is established on a regulations deriving from the case-practice of the European Court of Justice. According the specifics of the legal acts, the legal framework on free movement of goods, services, capital and labor force is analyzed separately, and at the end the students can understand the complexity of the whole system and its carriers in the European Union.
